Innovation Fund Foundation, Inc. Annual Report

¹ The Foundation was assessed a late filing penalty fee for 2014 Form 990. The Foundation attempted to file the 990 Form taxpayer but was unable to do so because the EIN was not in the IRS taxpayer system. Contact was made with IRS, and the IRS representative indicated the EIN would be added and that no fees would be assessed for late filing. Once the EIN was added, the Foundation filed the 990 form, and a penalty was assessed. The penalty fee was successfully appealed and the IRS refunded \$2,454.50 plus accrued interest of \$14.52. This refund occurred in FY2017 and therefore is not reflected above.
