#### **Annual Evaluation of Progress towards Contracted Goals**

In 2011, Rabun County Schools (RCS) entered into the Investing in Educational Excellence Contract (IE<sup>2</sup>) with the State Board of Education as defined by Georgia Code §20-2-80 - §20-2-84 and the Georgia Department of Education (GaDOE) Rule 160-5-1-.33. By law, the Governor's Office of Student Achievement (GOSA) must annually monitor RCS's progress towards meeting its contracted IE<sup>2</sup> performance goals.

The overall goal of the contract is to close gaps for all students and subgroups in reading and English/language arts (ELA), mathematics, and science between the school's performance and the state average within five years. To accomplish this goal, GOSA, the GaDOE, and RCS developed annual performance targets in each subject to track progress using the all students group and the same subgroups used for the purpose of determining Adequate Yearly Progress (AYP) each year for federal accountability requirements. These subgroups are Asian/Pacific Islander, Black, Hispanic, American Indian/Alaskan, White, Multi-Racial, Students with Disabilities, English Language Learners, and Economically Disadvantaged students.

RCS selected the following measures for the evaluation:

#### **Primary Schools**

- Percent Exceeds on Grade 3 Reading/ELA Criterion-Referenced Competency Test (CRCT) for students who attended respective school in 2<sup>nd</sup> grade the previous year
- Percent Exceeds on Grades 3 Mathematics CRCT for students who attended respective school in 2<sup>nd</sup> grade the previous year

#### **Elementary School**

- Percent Exceeds on Grades 3-6 Reading/ELA CRCT
- Percent Exceeds on Grades 3-6 Mathematics CRCT
- Percent Meets + Exceeds on Grades 3-6 Science CRCT

#### Middle School

- Percent Exceeds on Grades 7-8 Reading/ELA CRCT
- Percent Exceeds on Grades 7-8 Mathematics CRCT
- Percent Meets + Exceeds on Grades 7-8 Science CRCT

#### **High School**

Percent Exceeds on American Literature and Composition End of Course Test (EOCT)

- Percent Exceeds on Math I EOCT
- Percent Meets + Exceeds on Biology EOCT

The guidelines below have been used to determine if a school met or did not meet its annual performance targets and whether each year counts as one of the school's three years of progress.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> In 2013, House Bill 283 removed the requirement that schools meet annual performance goals for "three consecutive years."



A school will be deemed as meeting its yearly performance targets if, within a 95% confidence interval:

- a) The school did not miss more than one subgroup target in a given subject area, AND
- b) The same student subgroup did not miss a target in more than one subject area.

Beginning with the 2011-2012 evaluation, GOSA implemented a "second look" option for schools that do not meet targets within the parameters described above. The second look option allows for schools not meeting targets to receive a holistic review through the CCRPI score. If a school has missed its targets, it will be deemed as meeting its yearly performance targets if:

• The school's CCRPI score is in the 85th percentile of CCRPI scores across the state within its grade cluster (Elementary, Middle, and High School clusters), as long as the 85th percentile score does not fall below an absolute CCRPI score of 85.

## 2011-2012 Evaluation Results Summary

Rabun County High School did not meet its targeted goals for Year 1 of the RCS IE2 Contract. Rabun County High School missed more than one subgroup target in a given subject area (American Literature & Composition—All Students and White), and its 2011-2012 CCRPI score of 82.8 is below the 85th percentile.
